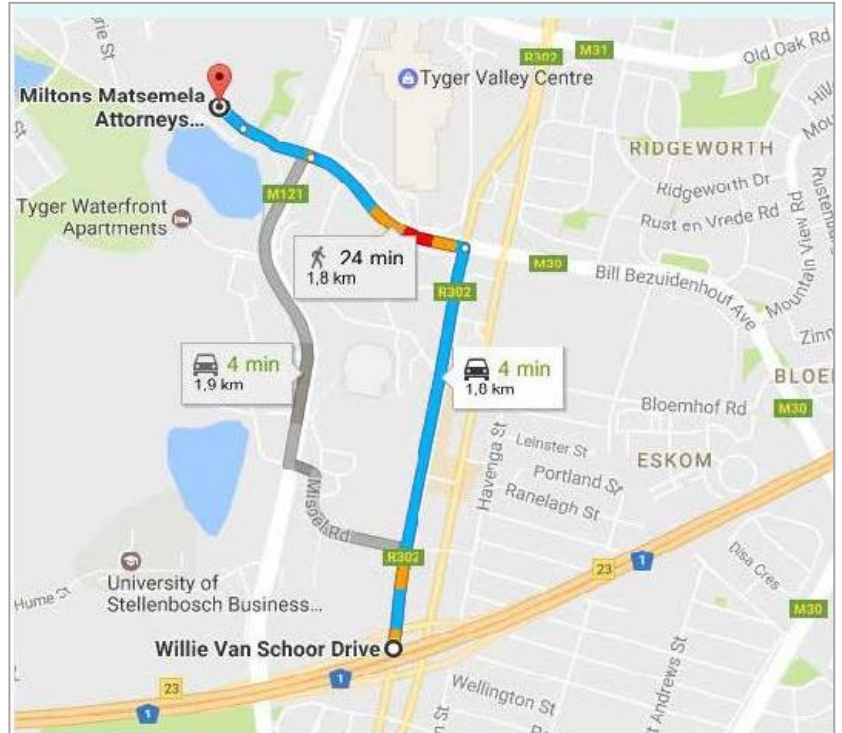

- Follow Bill Bezuidenhout Ave for 500m until the intersection with Carl Cronje Dr/M121
- Continue straight over the robot into Tyger Falls Blvd, which is a restricted road with security
- Go along Tyger Falls Blvd for 210m and straight at the mini-circle, onto Bridal Close
- The new CRF offices are on the left in the Combined Head Quarters, Bridal Close, Bellville, Cape Town, 7530
- Ask at the security desk on the corner of the building
