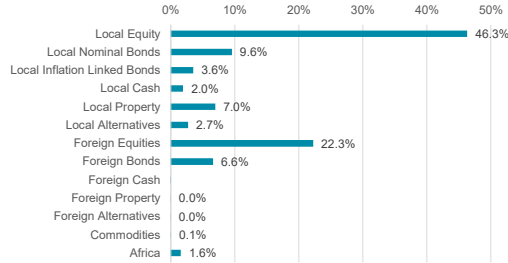

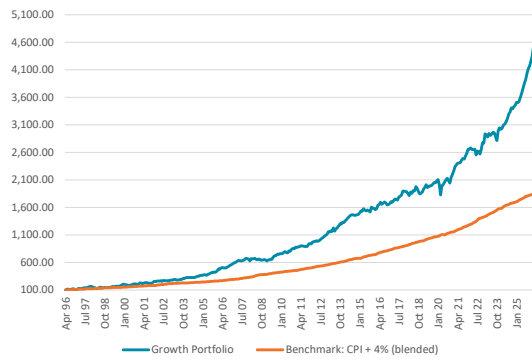

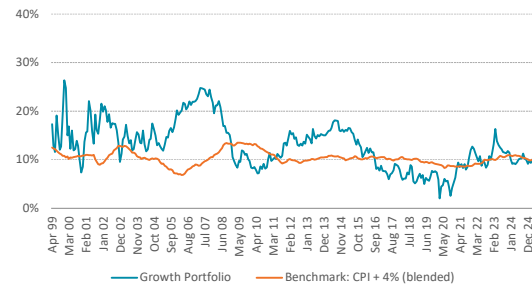
ASSET CLASS BREAKDOWN
